Dear Customer,

The purpose of this letter is to inform you that Bluetree Group has issued a field safety notice relating to Obisk Type IIR Masks. A problem has been identified with masks manufactured using a particular batch of material. The product meets the requirements for bacterial filtration efficiency, microbial cleanliness and breathability however it does not achieve the required splash resistance to be categorised as a Type IIR. As such it offers infection control equivalent to a Type II surgical mask with the breathability performance of a Type IIR.

Description of the problem

The main intended use of medical face masks is to protect the patient from infective agents and, additionally, in certain circumstances protect the wearer against splashes of potentially contaminated liquids. Although the masks affected achieve this main intended purpose, protecting the patient from infective agents, the batches identified below do not achieve the splash resistance required by the BS EN 14683:2019 standard to protect the wearer against potentially contaminated splashes.

As of 26th October 2021, there have been no reports of harm associated with this issue.
